The site is located adjacent the existing Davuilevu Subdivision approximately 6.0km from Nausori Town, and is accessible via Davuilevu Road off Kings Road. The construction works will consist of completion of sewer reticulation, completion of water reticulation, Storm water Drainage, construction of driveways, railings, and site clearing & earthworks.
