The Partially Developed Tavakubu Subdivision comprises of approximately 26.4 Hectare of Housing Authority Lease. The site is located to the North of the Saru Back Road in Tavakubu on an elevated piece of Crown- owned land approximately 3.5km south of Lautoka City. The construction works will consist of completion of roadworks, concrete structures, sewer reticulation, stormwater drainage, overslip remediation, electrical installations, water supply reticulation, together with associated preliminaries, general works, and site preparation.
